## The Charlotte Jensen Native Arts Market at the Dimond Center

### Rules and Regulations (Please keep for your own records)

1. The Charlotte Jensen Native Arts Market (CJNAM) will be **Wednesday, February 25th, 2026 thru Sunday, March 1st, 2026.**
2. The hours of the show are: Wednesday 10:00am to 6:00pm / Thursday 10:00am to 6:00pm / Friday 10:00am to 6:00pm / Saturday 10:00am to 6:00pm / Sunday 12:00pm to 5:00pm
3. Setup begins at **9:30am Wednesday-Saturday**. Set up at **11:30am on Sunday**.
4. We will assign tables to artists at check-in on the 1<sup>st</sup> day of the event **This show is in the Mall and they can sell floor space at any time. The floor plan can change at any time. Flexibility must be maintained with the facility and compliance with the Fire Marshall or other situations out of our control. The floor plan is subject to change at any time and spaces CANNOT be guaranteed.**
5. **TABLE SPACE IS 6 FEET LONG BY 2.5 FEET WIDE.**
6. **FIRE REGULATIONS PROHIBIT RACKS/EASELS AT THE END TABLES OR IN AISLES. IF SAFE TO DO SO, THEY MAY BE PLACED ON TOP OF TABLES. A TABLE (6 FT. X 2.5 FT.) OR A SPACE (ALSO 6 FT. X 2.5 FT.) . Request your space carefully as changes may not be able to be accommodated, but all attempts to resolve space issues will be considered.**
7. Unfortunately, we do **NOT** have electricity available for your use.
8. Sale of homemade foods (i.e. fry bread, seal oil, dried or smoked fish, pickled fish, etc.) is **prohibited by law**. Greater Anchorage, Inc., does not hold a food permit or liability insurance for food sales. Sale of food will result in forfeiture of your table and possibly jeopardize your participation in future shows.
9. (a) **All crafts sold must be made by an Alaska Native who belongs to an Alaska Native Corporation.** Your native corporation must be listed on your rental agreement along with your U.S.-issued BIA membership card number and tribe of origin.  
  
(b) The show management reserves the right to remove any vendor who is selling items that are not authentic. The emphasis of the show is traditional, quality arts and crafts, handmade, by traditional methods by Alaskan Native Americans from traditional raw materials. This does NOT include things such as ceramics, laser cut, laser printer produced or engraved materials, machine stamped products, products assembled mostly from store purchased items, etc. Skill and quality are emphasized and valued. **THE SHOW CHAIRPERSON'S DECISION(S) ARE FINAL.**  
  
(c) We encourage you to have a silver Hand Program Permit. These need to be renewed every 2 years.  
  
(d) The Grandfather Clause is no longer in effect. Only Alaska Natives who meet the above defined requirements will be eligible to participate in the Anchorage Fur Rendezvous Alaska Native Arts Market. This is a 2010 policy passed by the Anchorage Fur Rendezvous Board and is based on the organization's mission to serve Alaska Native Artists.

10. All Arts and Crafts for sale must be original and made by an Alaska Native person who is a member of a federally recognized ANCSA Alaska Native Tribe. A copy of a current U.S. BIA card and/or an Alaska tribal enrollment card is proof of enrollment. Your regional Alaska Native Corporation must be listed on your rental agreement.

***\*Original work means new and unique work created or crafted by one person and is not a reproduction. Authentic Alaska Native art means a work of art that is created or crafted by an Alaska Native person. This is an additional way to authenticate your work and protect you and your patron from Alaska Native art fraud.***

11. By signing the attached application and initializing the rule pages, you agree that you will not display or sell **ANY** merchandise that does not meet the requirements of above. Not following these requirements will result in immediate forfeiture of your space and you will **NOT** be eligible for any refund of your booth space fees.
12. **Check In procedure and Mall rules.** Check-in in at the registration area before 11:00am opening day. You are not guaranteed your table location until you check in and "claiming" tables is not allowed and can result in removal from the event. For Mall security, Mall doors and stores do not open until 9am. **Propping open locked doors for access before 9am is strictly prohibited** and may end mall use for CJNAM show to be denied. There are no exceptions to the Mall rules.
13. **Tables must be manned at all times.** Please note the hours above and know that someone must be at your table every day during all show hours or you will **forfeit your table** and your table fee and possibly your ability to participate in future years.
14. Neither Greater Anchorage, Inc. (dba Fur Rendezvous) nor the Dimond Center is responsible for any items stolen or damaged.
15. Merchandise or items containing the name "Fur Rendezvous" (or any deviation of the name) or having the Rondy logo or button design must have prior written approval of Greater Anchorage, Inc. This pertains to any wholesale, retail or giveaway items. This is a legal requirement.
16. Children must be supervised at all times and may not disrupt other vendors. No running near other vendors or on escalators.
17. CJNAM does not allow items (pamphlets, brochures, cd's etc.) that are political or religious in content. All material must be original works of art, made by an Alaskan Native.
18. You may not sell, trade, barter or otherwise transfer or give the use of your table space to another artist without the prior approval of Fur Rendezvous staff. Any such action will be null and void and all parties involved shall be removed from the show. The artist originally assigned the table may be banned from future shows. All Vendors must sell from the assigned spaces.
19. These rules are subject to addendum or change at any time. Some of the changes may be out of our controls (ie: Municipal Mandates, CDC Guidelines, etc.) and additional guidance during pandemic or epidemics as mandated and approved prior to the event.

**\*TABLE FEES ARE NONREFUNDABLE EVEN IN CASE OF CANCELLATION ON YOUR PART.**
